

**General Information**

Use this form to:

- Calculate any payment due for a valid tax year 2025 extension.
- Make estimated payments for tax year 2026 (check the appropriate year on the voucher below).
- Make payments of Qualified Investment Exemption (QIE) recapture when you don't file your income tax return by the due date. Write "Payment of QIE Recapture" at the bottom of the voucher below, and return it with a check.

**About payments for extensions.** If you can't file your 2025 Idaho tax return by April 15, 2026, you qualify for an

automatic extension to file, if you pay at least one of these:

- 100% of the income tax on your 2024 return (if you filed). You can't use this method if you've never filed in Idaho.
- 80% of the estimated tax due on your 2025 return.

Complete the worksheet below to calculate payment due for the filing extension. You must pay that amount online or postmark it by April 15, 2026. If it's \$50 or less, you don't have to pay it now to get the extension.

**There's no extension for paying.** We must charge interest on any tax due that you don't pay by April 15, 2026.

If you qualify for the extension, file and pay by October 15, 2026. Penalties can apply. See: [tax.idaho.gov/extensions](https://tax.idaho.gov/extensions).

**Tax Payment Worksheet.** (Keep for your records.)

  - Multiply line 5 by 80% ..... 6. \_\_\_\_\_
  - Enter the lesser of line 1 or line 6. If you didn't file a 2024 tax return, then enter the amount from line 6 ..... 7. \_\_\_\_\_
  - Idaho income tax withheld on your 2025 return. Form 40, lines 46 and 48; Form 43, lines 66 and 68 ..... 8. \_\_\_\_\_
  - 2025 Form 51 payments on your 2025 return. Form 40, line 47; Form 43, line 67 ..... 9. \_\_\_\_\_
  - Add amounts listed on lines 8 and 9 ..... 10. \_\_\_\_\_
  - Payment Due. Subtract line 10 from line 7. Enter "0" if the difference is a negative number ..... 11. \_\_\_\_\_
- The amount on line 11 is the minimum you must pay to get a valid filing extension. On line 12, enter any more you want to pay now to reduce tax you owe, and the interest it will accrue.
