**Call TXB002** to see if you have any invalid code areas.

All homeowner information **must** be complete prior to printing your notices because it is included in the calculation for current year value.

**Summary Sheet Reminder**: if you would like the PMB117 at the end of this checklist to give you new summary sheets (all changes on one summary sheet), you need to **answer** "**Y**" to summary sheets for each roll.

**NOTE**: When you back up UADFILE, use the option on the Go Back menu to initialize and save UADFILE. (**16G or higher tape drive counties** using QIC5010 tapes should follow the instructions on page 35 of this checklist.) OR – use your county specific backup.

#### 1. **PMB189 - List Property Types**

Run this program to determine the property types used in your county and to select the limits needed for this checklist. (Typical "main roll" parcel types include: LP, LR, MH, PP, RP, and SC.)

#### 2. PMB008 - List Value per Acre - OPTIONAL

If <u>all</u> of the county's rural investment has been entered in the subsystem and the subsystem roll program will be used to populate the category value in **Parcel Master**, it will not be necessary to run this program. Run this report to verify that no excessive values per acre have been entered. Run on each category <u>separately</u> (cat 1 - 7) in ascending value order. (Will not list parcels with 0 quantity.)

#### 3. A. PMB131 – Edit Related Parcels

This program will edit for related parcels. Run options 1-3 separately to cut down on the size of the reports. \*\*If parcels are not related correctly and you fix them, you need to run **PMB101** to see the correction on a PMB012. (You can run this now or at step #9A. (Requires dedicated files.) If you need to break a relationship, note any HO market – it will get wiped out and will need to be reentered.

#### B. **PMQ015 – List Invalid Categories** (8, 44, 60, 61, 62).

This should be clean. Alan Dornfest expects to see zero value for these categories on the Abstract. The 60-62 categories should have been replaced with either a 50 (residential) or 51 (Commercial).

#### C. PMQ010 – Edit for Bad Sheet Numbers.

**PMQ010SHT0**: All Sheet Zeros **have to be cleaned up**. These can be fixed by opening the category screen (F8) in update mode. This will change the zero (blank) to a '1'. Rerun to verify that they have been cleaned up.

**PMQ010RCCT:** No matching Sheet #. Parcels that do not have a matching sheet in the RC Subsystem should be reviewed.

4. PMQ002 - List Expiration Dates (If nothing prints on this report, skip to step 15.) Run this report to make sure the run date to be used when executing PMB081 covers all of the "inactive" parcels to be rolled. If not, then you will need to check whether you need to change the date in Parcel Master on those "inactive" parcels, or if you need to use a different run date for PMB081. If any "I" status parcels without an effective date show on this report, correct them before proceeding. Also, check for parcels whose effective date is equal to the expiration date since these parcels will go to a "T" status. If you have an "I" parcel with an expiration date, make sure the "A" parcel does not also have an expiration date. If you want both to expire, you will need to hand delete the "I" parcel.

#### 5. **PMB181 - Compare Effective and Expiration Dates**

This program compares "I" status effective dates with corresponding "A" status expiration dates, and lists them if they are different.

#### THESE PARCELS NEED TO BE INVESTIGATED AND FIXED BEFORE CONTINUING.

- 6. **\*\*NOTE**: If it takes a long time to run a TXB040, you can instead run a **TXB020** for **EACH** year with outstanding taxes.
- **TXB040** A. Run a listing of tax due records in parcel number order.

OR Use the limits BLANK to 30 999, and put the report on HOLD.

**TXB020** Answer **2024** for the current tax year and the "enter date interest valid" should

(each year) be the same as the run date on your PMB081. For the TXB040, accept the default answers on the rest of the prompts except answer "N" to 'Print Legal Description'. For the TXB020, B, Detail, Full, N, Detail.

This report will be compared to the TXB040/TXB020 run after PMB081 (step 14A) to ensure no tax records are lost.

## The Treasurer cannot post between steps 6A and 14A – if they do, it will keep you from balancing.

B. **PMB098** - This program cleans up subsystem files with no matching Parcel Master. **\*REQUIRES DEDICATED UAD FILES\*** 

#### C. PMB318 – File Status Report

This program gives a record count of the data files.

#### 7. **RCB006 - Edit for "A" and "I" Parcels.**

Run this program before PMB081 to check the "I" against the "A" to see if changes may have accidentally been made to the "A" parcel instead of the "I". This program checks the Residential Characteristics file.

#### 8. TXB127 – Create Tax Cross Reference Records for "I" Status Parcels.

You only need to run this program if you are running PMB081 (steps 10-14). You will need Treasurer's security in order to run the program.

#### 9 A. **PMB170** – HO Edit Before Rolling

This edit will list any parcels that have a homeowner exemption amount but no HO record or if they are not related to a parcel with an HO record. These need to be cleaned up before continuing.

If you received and cleaned up PMB170 edits above: (or in step 3A)

- 1) **Run PMB101** This will reorganize the file to accept your changes.
- 2) **Rerun PMB170** to make sure it is now clean.

#### B. **PMQ081** – List Inactive Parcels without a HO Record

Keep this query in case you are out of balance after PMB081 (step 13C). It will list "I" status parcels that may not be picked up by the PMB012 "I" in the pre PMB081 balancing reports.

## 10. **PMB081 - Inactive Roll – NON – update.** Run with No-Update. REQUIRES DEDICATED UAD FILES

It is very important to investigate the parcels that appear on this report. 'I' records with an effective date prior or equal to the run date keyed in will become an 'A'. 'A' records with an expiration date prior or equal to the run date will go to a 'T'.

If you are unsure about a particular parcel, use Parcel Master Inquiry to examine the parcel carefully.

'I' records that have an effective date greater than the run date and 'A' records with an expiration date greater than the run date will not be affected.

## REFER TO THE DOCUMENTATION FOR PMB081 FOR PROGRAMS THAT NEED TO BE RUN <u>AT THIS TIME</u> (Step 1) AND USED TO BALANCE PARCEL MASTER LATER IN THE CHECKLIST. (The doc was sent with the release.)

Use \_\_\_\_\_ to 30 99999999 as your limits for each of these reports: PMB002 on "A" status and then again on "I" PMB012 on "A" status and then again on "I" (Summary of all) PMB012 on "I" HO only in Detail. (HOLD, use if out of balance) DO NOT make any changes in Parcel Master after the reports have been run until after PMB081 has been run in update.

An Excel spreadsheet was sent out with the Revise package. Use this spreadsheet to enter your figures from the above reports to balance the PMB081. The spreadsheet will automatically calculate the totals for you once all figures have been entered. Or, you can still use the balance sheet on the last page of the PMB081 documentation.

  - B. **PMB101** Reorganize Related Parcel File. Requires dedicated UAD files.
  - C. Refer to PMB081 documentation for the "after" balancing reports that need to be run. To Balance, complete the Excel spreadsheet sent with the Assess Drive package, or use the "balance sheet" on the last page of the PMB081 documentation. Balance to the reports run in step 10:

#### 14. Tax Due Listing

TXB040 A Run with the same responses used in Step 6A. (If you ran TXB020s

ORinstead of the TXB040, please do so again.) Be sure to put the report onTXB020HOLD. Compare with the TXB040/20 that was run before PMB081. Display<br/>the totals at the end of the report. Tax, late charge, and cost should not<br/>have changed from the previous TXB040/20. (Interest, and therefore total,<br/>may change if the reports were run on different days.) Once you have<br/>determined that they balance, you can delete both reports.

#### B. PMB318 – File Status Report

Compare this report with the one run in Step 6C. You should see change reflecting what you rolled with the PMB081. If there is a significantly larger change than expected, call TSB at 1-800-334-7756.

15. **FACTORING (TRENDING) PARCEL MASTER VALUES.** If this does not apply, continue with step 16. You may choose to trend in the subsystems – this is addressed at the start of each subsystem roll. #### 16. Call FIXRCLRC – Update Last Record Number in Parcel Master

You may have balancing problems if you do not run this program. **ProVal Counties** only need to run this if they still have parcels in the subsystems.

#### 17. PERSONAL PROPERTY PROCEDURES.

If this does not apply, continue with step 18.

• House Bill 565 (signed 03/25/2022) expanded the definition of transient property. If you have a personal property asset that meets all **three** of the following tests, it is no longer taxable and should be deleted. (Not eligible for reimbursement.)

Self-propelled, self-powered, or pull-type equipment and machinery; And
 Primarily employed for the use of construction, logging, or mining of salable minerals as defined in section 47-701A, Idaho Code; And
 Designed to travel to various job sites.

#### A. PPB175 - Update PP Last Record in Parcel Master

**REQUIRES DEDICATED UAD FILES**. This program will update the last record number for the personal property subsystem and needs to be run. (This program does not generate a report.)

#### B. **PPB074 - Compare PP Categories with PM Categories**

This report verifies categories between Parcel Master and the Personal Property file and **needs to be clean before proceeding.** For "Review Year Not = to U-Year", **answer "N**".

#### C. **PPQ030 – List PP Inventory Records with no Category**

This will list any PP inventory records with a blank category. (Except those with function codes 98 and 99). **These need to be fixed before proceeding**.

#### D. **PPB073 - PP Unreturned Report List**

You can run this "With Inventory", "Without Inventory" or "Both". **Answer "Y"** to the prompt "Require PP cat in Parcel Master". Only parcels with your selected minimum value (eg. \$200,000) and a Personal Property category in Parcel Master will appear on this report. It will also print any parcels with a PP category that is not eligible for the exemption and should be reviewed and might need its review year updated so it's value will roll in.

NOTE: Parcels that appear on this report with the comment "Review Date XX" (XX being other than current year) will not roll into the Parcel Master. These parcels need to be investigated before proceeding.

#### E. PPB089 – List PP Inventory By Selected Category

Review inventory DESCRIPTIONS on categories **56**, **59**, **63**, **64**, **68**, **71** & **72** to verify that they qualify for the PP Exemption. (These categories will automatically receive the PP Exemption when you run the MSB020.) The report will pick up parcels with a 2025 Review Year in the subsystem. All of these categories WILL get the PP exemption. If it should not receive the exemption, it needs to be changed to a different category, ie 45 or 57.

**Remember**: Buildings, Cell Towers, RVs, boats, float boats, aircraft, other motor vehicles, and Manufactured and Mobile homes **ARE NOT ELIGIBLE** to receive the exemption. If they are listed with one of the eligible categories they need to be moved to different category (eg. 45 or 57) so that the exemption is not applied to them.

You need to manually apply the exemption to any cat 45 and 57 that have legitimate personal property items. This will be done in step #17S.

F. **PPB010 – Inventory \$3,000 or less with a Purchase date after 1/1/2013** Any inventory less than or equal to \$3,000 purchased after 1/1/2013 is exempt. Either remove from inventory, or give it an extended value of zero.

#### G. **PPB823 - PP Review Year Edit**

This program needs to be run before the review year is rolled into Parcel Master. Answer " $\mathbf{Y}$ " to the prompt 'Do you want to include parcels which will be updated?' That way you will only see parcels that will be updated. (Review Year 2025.) Review and make corrections before continuing.

#### H. PMB002 - Category Recap

Run on the same limits you intend to update.

#### I. PPB086 - PP With Inventory Recap

This recap report lists parcels from the Parcel Master file with personal property categories and Personal Property Inventory.

#### J. **PPB085 - PP Without PP Inventory**

This recap report lists parcels from the Parcel Master file with personal property categories but no inventory and/or with unreviewed personal property inventory.

Select option (1) w/o Personal Property Inventory

Balancing procedure (Balance P/P Categories only):

PPB086 (Step I)

#### K. **PPB076 - PP Category Recap with Inventory**

Gives category totals from the Personal Property file –use current review year.

#### L. **PPB085 - PP Without PP Inventory**

This recap report lists parcels from the Parcel Master file with personal property categories but no inventory.

**Select option (2)** w/o Personal Property Inventory, and with unreviewed Personal Property Inventory. (These parcels **will not roll**.) Use 2025.

- **NOTE**: If you have any QIE exemptions, please verify that they have been updated for 2025. (i.e. has the 2<sup>nd</sup> year been entered?) Use PPB090 to get a QIE listing.
  - M. **PMB078** Create category file backup UACATGAS. (Answer Yes to replace.)

#### N. **PPB079 - Roll PP Values to Parcel Master**

**REQUIRES DEDICATED UAD FILES.** \*\***Remember summary sheets. Select Review Year 2025**. PPB079 merges the values from the Personal Property file to the Parcel Master file and lists the Personal Property accounts. (You will receive 2 reports: PPB822 shows the updated review year and PPB079 shows the parcels that were updated.)

Carefully check the % change column on the PPB079 and look for anything that might be out of the ordinary, ie excessively large increases/decreases. \*\*If you don't print the report out and are viewing it on your computer screen, you might need to F20 TWICE to see the +/- sign to the right of the % change.

#### P. PMB002 - Category Recap

**<u>NOTE</u>**: If you have any parcels that qualified for the QIE exemption, please double check to make sure the correct value is in Parcel Master. (The exempted amount should NOT have rolled in.)

#### Review/Update Ownership Codes:

List Ownership Codes: PMQ050 (runs and goes to spool file)

This will list any parcels WITH an owner code.

To help find common owners who may not have an ownership code: **Call PPNAMELIST** (name order) and **Call PPADDRLIST** (address order).

#### Update/Add Owner Codes: PMO008

Ownership Code is a 4 digit alpha/numeric field that can be used to identify parcels with the same ownership. (You can use numbers, letters or a combo of both for the code to identify an owner.) Use this to help edit and monitor the PP exemption for those taxpayers with multiple PP parcels so that you can make sure the total PP exemption does not exceed \$250,000. We will use this to automatically apply the exemption to taxpayers with multiple parcels that total less than \$250,000. (Those over \$250,000 will kick out on an edit. This will allow you to either apply the exemption to the code areas selected by the taxpayer or apply them yourselves.) Ownership is huge in determining if a parcel should or should not receive the exemption. If you have questions about ownership, please contact your Consulting Appraiser.

Instructions on how to enter the **Ownership Code** are on our website: <u>Counties Technical Tips</u> <u>Idaho State Tax Commission</u>. ("Owner Code Entry/Update")

Remember, you only need to apply an ownership code to those multiple parcels that tie back to one "owner". (eg Simplot. No matter what name is being used, an entity only gets one \$250,000 exemption per county. So, if you have an owner code of "Smpt" you can add that to parcels labeled JR Simplot, J.R. Simplot, Simplot, JR, Nabisco, etc. The ownership code is what will be used to pull them altogether.)

#### Q. MSB020 – Apply/Update PP Exemption Up to \$250,000

Automatically applies/updates the exemption to categories 56, 59, 63, 64, 68, 71 & 72.

(It will **not** auto apply to categories 45 & 57. See step S.)

This program will apply the PP Exemption up to \$250,000 to all parcels with single ownership and all ownership codes that total less than \$250,000. Those ownership codes that total OVER \$250,000 will kick out on an edit at the end of this report. You need to HAND APPLY the exemption to these

**parcels** – either by the manner requested by the owner or in the manner selected by the county. (When done, do **not** rerun MSB020.)

MSB020 will reapply the exemption to any fully exempted parcels from prior years. It will recreate the exemption based on the value and zero them out.

**NOTE**: The PP Roll program (PPB079) removes all PP exemptions. The MSB020 will reapply the exemption to all parcels **except** those > \$250,000, those with an owner code, and cats 45 & 57. You will need to review and manually update these each year.

#### R. **PPQ035 – List Orphan PP Codes in Hardship File**

All parcels that appear on this edit need to be cleaned up.

If the parcel had the PP exemption in 2024 on the category listed on the report but now the exemption is on a different category, or if the parcel is not getting the exemption this year, please go into Parcel Master Entry/Update, into the category window (F8), then into the Market Adjustment (F6) and clear (field exit through) the category listed on the report.

If the parcel has been deleted (T status) but it still shows the market adjustment, call TSB. TSB will need to go into the market adjustment file and remove it.

Once these changes have been made, **please rerun PPQ035** to verify that the report is now clean.

#### S. **PPB030 – Edit for Category 45 and 57.**

This report will list all category 45 and 57 parcels. You will need to determine if the parcel is eligible for the PP exemption in full or in part and then **manually** apply the exemption.

To apply the exemption by hand for the cat 45s and 57s that might qualify, use the "**Market Adjustment Entry/Update**". (In Parcel Master, F8 to category screen, then F6.) Use code "PP": <u>Counties Technical Tips | Idaho State Tax Commission</u>

#### T. **PPB020 – PP Exemption Over \$250,000 Edit**

Please review and correct. No owner should receive over \$250,000 in PP exemption. After correcting, please rerun to verify all have been cleaned up.

Please let Jerott Rudd at STC know if you have any locally assessed PP Exemption that may also have Operating Property parcels (UP/UR) that would qualify for the PP exemption. (Jerott.Rudd@tax.idaho.gov) Jerott needs to be notified as soon as possible, but no later than the 3<sup>rd</sup> Monday of June, of any locally granted PP exemption to a company that may also have state assessed utility value so that the company will not receive more than they should. OPT takes the PP exemption value off the top of a company's full value prior to it being entered into the State system. That value will then be spread to the counties based on line miles, etc. Since it is taken off the top, you will not see a PP exemption on any utility parcels, and therefore you will not be able to adjust them if they go over \$250,000 in your county. (That is why it is important to let Jerott know as soon as possible if you gave any local PP exemption.) When you load your Utility values in September, you will only load the adjusted market value.

To help determine if you have any cross over, please run the two queries below. Compare the **PP**Name to the **U**PName and notify Jerott if you have the same name on both lists, or a company with a similar name. (Chevron USA vs Chevron USA, Inc, etc.) **Suggestion:** print out the **U**PName report and compare it to PPName **on the spoolfile**. (the PPName might be pretty long.) They will show as QPQUPRFIL on the spoolfile.

18. **RESIDENTIAL CHARACTERISTICS PROCEDURES.** If this does not apply, continue with step 19.

A. Programs are available for factoring (trending) the Residential Characteristics subsystem. If you need to update multipliers (trend) in the RC file, you will want to do so before rolling the RC subsystem values into Parcel Master. Refer to the documentation for **RCB004** to update RC multipliers.

**Decrease** by 5% (from 100 would be 95, so = 0095000000 **Increase** by 5% (from 100 would be 105, so = 0105000000

#### B. **RCB017 - Edit Review Year with Parcel Master**

Answer "N" to the prompt "Do you want to include parcels which will be updated?" That way you will only see parcels that will <u>NOT</u> be updated. This report needs to be reviewed and corrections made to the RC file before continuing this checklist. The review year roll program is embedded in the RC values roll program (RCB003).

#### C. RCB009 - Edit Other Multipliers.

This program will list possible problems with RC other multipliers. Parcels with "other multiplier descriptions and no factor" **MUST BE CORRECTED.** 

#### D. RCB016 - Edit Residential Characteristics file.

All correctable edits should be eliminated before proceeding. Answer "Y" to the prompt "Include totals for balancing?" If totals are given, use them in Step O to balance.

#### RCQ004 – List Parcels with "N" in Exempt Field

If any parcels show on this report, see if they should be exempt or not. If they are exempt, you need to have a "Y". If they should not, remove the "N".

#### E. RCB016 - Edit Residential Characteristics file.

If edits were cleaned up in Step D, it is a good idea to run this program again, and answer "Y" to the prompt "Include totals for balancing?" If totals are given, use them in Step O for balancing.

#### F. MSB018 - Edit Exempt RC & MH with Value in PM

Lists all exempt RC or MH records that have value in Parcel Master. This same listing can be used for step 19G.

#### G. PMB002 - Category Recap

Execute on the same limits you intend to update.

This should be clean. Alan Dornfest expects to see zero value for these categories on the Abstract. The 60-62 categories should have been replaced with either a 50 (residential) or 51 (Commercial).

28. Create New Land Homeowner Exemption Records. **This is optional** for full AS/400 counties. If you use ProVal, skip step 28A-D. If you split into duplicate categories during the land rolls and updated your homeowner market, or if you have been updating the homeowner market in Parcel Master by hand, you do not need to do

these steps. Read what each one does before proceeding. Call if you have any questions.

**This program recalculates all HO records** - it will apportion the exemption between all eligible categories (if they have a HO market) and between related parcels. It will also cap the HO at **\$125,000**. (Don't use the totals to balance.)

#### 32. **PMB012 - Exemption Value Summary.** Run in Summary.

The **HO Market Value** total (below) should be the same as the PMB012 from step #30. The exemption amount will be different as the MSB009 recalculated it step #31.

PMB012 – Also **run on Market Adjustment Data** and check the totals at the end of the report. You can select all or specific Market Adjustment codes. Do your high end exemptions total what you think they should? (Like IE)

\*\*Developer's Exemption W4: Reminder, the Developer's no longer lose the exemption when they start construction (foundation, etc) on an improvement. (It still comes off when the property sells.)

#### 33. PMB025 - Edit Exemptions and Specials (PV and non PV Counties)

Run on "A" status. Edit and clean up all exemptions except Circuit Breaker (say "N" to the CB edits, they will be edited during step #51A.

The following edits <u>must be investigated:</u>

"Homeowner Value but No Homeowner Record"

"Homeowner Record but no Homeowner Value"

"Total Homeowner Exemption Amount Exceeds the Maximum"

"Homeowner (Value) Parcel Master (Value)"

"Homeowner and/or Market Adjustments Greater than Market Value"

"Homeowner on Land but Not on Improvement"

On parcels with a HO market different than a PM market, check to see if you need to put an "X" for <u>not 50%</u> in the HO record. Parcels with HO value greater than Parcel Master value will result in a negative difference and **must be clean**.

#### 34. **PMB369 - Parcels Not at 50% Homeowner**

This program has two reports. ReportA will list any parcels that have a homeowner exemption value that exceeds the maximum allowed. ReportB will list all HO market records marked as "not at 50%" AND parcels where the HO exemption is not half of the HO market. Review this report carefully, and make any necessary changes.

Remember, the Residential Characteristics and Mobile Home roll programs did **not** update the homeowner market and exemption amounts if the homeowner record is marked X "Not at 50%" and there is no entry in "% Applicable".

#### 35. OPTIONAL - PMQ070 – Parcel Marked as "Not at 50%"

This query will only list parcels marked at "Not at 50%". Run this if you would like to see them split out from the PMB369 report (step 34).

#### 36. Optional Edits:

- A. PMB010 List Out of County Owners Look for out of county zip codes with a homeowner's exemption.
- B. PMB093 Parcel with Homeowner by Select Cat/Acre Run this to double check land categories that are greater than one acre with a homeowner exemption.

#### 37. **PMB013 - Edit Parcel Master (NOT optional)**

If when you look on the spool file for the PMB013, it shows 0 pages and it will not let you view it to check your amounts entered, it could be sitting on an error message and the program did not complete. If you have a 0 page report that you cannot open, please call us.

It is VERY IMPORTANT to review the PMB013 edit report and look for parcels that may have excessive value.

#### 38. **PMB125 - Land/Improvement Review Year Edit**

**Optional**. This edit will list all parcels where the improvement review year is different than the land review year.

#### 39. **PPB020 – PP Exemption Over \$250,000 Edit**

Please review and correct. No owner should receive more than \$250,000 in PP exemption. After correcting, please rerun to verify all have been cleaned up. (If this was clean in step 17T and you have not changed any PP parcels, you can skip this step.)

**PMQ040** – List Market Adjustment Values not Matching the Category File **All** parcels that appear on this edit **MUST** be cleaned up. If not, incorrect values could be used on your Abstract. Call if any parcels appear on this report.

#### 40. Run PMB002 and PMB003

Be sure that these reports balance to each other, as they are the current year values before any corrections or Board of Equalization changes.

#### 41. **PMO062 – Enter/Update Taxing District Information**

You need to add or remove districts and update the phone number (if given) and hearing date for each taxing district. This information is required for the assessment notices. The County Clerk should have all of this information for you. You will be asked if the taxing district is in compliance (Y or N). \*\*If you don't already have it there, please add "208" (or new area code!) to each phone number.

\*\*Remove any judgments that no longer apply. You will need to get with your Treasurer to determine this. (Most are only good for 2 years.) For those that still apply, do you want them to print on the Assessment Notice? If yes, make sure you mark them "E" for not required to have a hearing date.

The districts are required to supply the Clerk with a hearing date. (They are not required to submit a phone number.) If they did not submit a hearing date, mark the compliance field with an "N". A "no response" will then print on the Assessment Notice for that taxing district. For the various school bonds, torts, etc., you can use the same date that you entered for the main school district. (Otherwise, it will list as "no response".) A June 24<sup>th</sup> hearing date is entered as 06242025.

If the district is not required to hold a meeting (eg. some hospitals) then put an "E" for exempt in the compliance field. (If you have the State as a district, mark that with an "E".) The notice will print "not required" for these taxing districts.

Run a **TXB612** to get a listing of the taxing districts entered into your 2025 file. Use this to proof to the PMO062 list to verify it is complete. (F14 while in the PMO062 will give you a list.) If you have districts on the TXB612 that are not on the PMO062, page down to the end of the list and enter the district number, hearing date and phone number. The name will auto fill for you and the districts will also automatically renumber when you hit enter. **Remember**, if you are updating for this year and select to print last year's taxes, the districts may be different. Print a notice to see if they are printing as desired.

#### 42. **PMO002 – Category Description Update**

If you would like to change how a category description appears on the assessment notice, you can go into this program and change it. Call the program and then page down to review the descriptions.

#### 43. MSO005 – Head File

Review the information for the Assessor's Office (record 2). This information will print in the return address section at the top left of the Assessment Notice. Update if needed. Add or update comment1 & 2 if you want them to print on the notice.

#### 44. Backup the UADFILE - **REQUIRES DEDICATED UAD FILES** See page 35 to save UADFILE.

\*\*If this is your **permanent record** (if you do not keep a copy of your assessment notices or a printed roll), ask your county attorney how long you must keep this tape.

#### 45. **PMB062 - Assessment Notices** (refer to documentation):

Limits – use your main roll limits. (See step #1.)

Make sure you enter the correct **current** year. (eg 2025. If you enter 2024, it will create notices based on 2023 taxes.) This year also prints at the top of the notices.

You must select **"Y"** for "Is this your **Main Roll**" in order for the taxing district hearing dates to show on the notice.

Any category 81s that have specials will only print if you answer "Y" to print cat 67/81, "Y" to print 0 market value for other parcels, and "Y" to last year's tax. The special will show up in the "fees" area of the notice (bottom left). \*\*All fees are based on LAST YEAR'S specials. Even if you have your current year's specials in, last year's will show on the notice.

**PP Exemption**: you are ONLY required to send notices to any NEW PP accounts that were zeroed out with the new exemption and of course for those still over \$250,000. (If they were a net zero last year, you do not need to send a notice again this year.) If you choose to send to all PP parcels, regardless if they are new or over \$250,000, then answer "Y" to the prompt: "Do you want to print zero net taxable Personal Property Notices?" If you answer "NO", then you will only get parcels with a 2025 review year. (Both zero net value and those over \$250,000.)

**BDS or MT**: If you send your notices to a print vendor, you select "**NO**" for the print to laser option. Vendors are set up to receive/read the file in that manner. Use the "**Assessment Notices to txt File**" instructions to create the file to send to them.

To print on the Assessment Notice forms, select "F".

**Estimated Property Tax: Please answer** "**N**" to this prompt as the STC is not sure yet if they will be providing this service again this year because of the uncertainty of what the new tax credits will do to the estimated tax.

The notice will print the prior 2 year's taxes and the % change.

For ease in aligning the forms, we suggest that you also run the Assessment Notice Program (PMB062) on 1 parcel only and request 10 copies so that you can use these to align your forms. When you have the proper alignment, release your spooled Assessment Notices and continue printing.

Once your notices are run, you can use **PMO063** to view or print a copy of the notice as created by PMB062. F9 and/or F10 will ask if you want "Copy", "Corrected Copy" or neither to print on the notice generated from PMO063. The program allows you to select by parcel or search by name or address.

#### 46. **PMB117 - Print Summary Sheets**

This program will print new Parcel Master summary sheets after "All" subsystems have been rolled and trended. (If you said "Y" to summary sheets when you ran each roll program.) It will only print 1 sheet per parcel. It will also give you the option to print new appraisals by subsystem. Parcels uploaded to the AS/400 from ProVal will print summary sheets.

#### 47. **PMB001 – Parcel Detail Listing**

If you want a printout showing the values and estimated tax that printed on the Assessment Notices, run this report.

- 48. Estimated Property Tax: STC is NOT doing this for 2025. We cannot be accurate enough not knowing what the new tax credits will do to taxes this fall.
- 49. YearComp Build Value Comparison File (Category Value Last Year/Current yr) Please run this program AFTER May 1st. (Call YearCompC). Answer "Y" to the prompt: "Are you running this during Assessment Drive?" This will create a file that your Consulting Appraiser will need to review at a later date. It will kick out a report for your information/review. Use your main roll limits.

#### 50. Ag Year Comp – Compare Ag Categories.

Please run this program AFTER May 1st. (Call YEARCMPAGC). Answer "Y" to the prompt: "Are you running this during Assessment Drive?" This will create a file that your Consulting Appraiser will need to review at a later date. It will kick out a report for your information/review. Use your main roll limits.

#### 51. **PROPERTY TAX REDUCTION:**

Make sure you have the PTRLoadData program installed before proceeding. If you need help installing it, or if you aren't sure whether it is on your machine,

please contact Kathy Pridgen (<u>kathy.pridgen@tax.idaho.gov</u> or 208-334-7753) for assistance.

A. **PMB025 – Edit CB Exemptions** (Only select "Circuit Breaker Data".) Investigate and clean up these edits:

"Circuit Breaker Value but No Circuit Breaker Record" (must be clean)
"Circuit Breaker Value XXXXX Parcel Master XXXXX" (some may be OK)
"Circuit Breaker Reduction Amount Invalid" (must be clean)
(If the parcel is listed because it has a CB record from a prior year, but they did not apply for the current year, then you can ignore the edit.)
"More than One "X" Record on a Multiple Application" (must be clean)
(Has 2 X records instead of an X and a Y.)

#### B. PMB520 – Median HO; PTR over 200% or \$400,000

**Run in Summary** – this will give 2 Summary Reports. (Summary & just PTR over the 200%.) The detail report lists ALL parcels with a HO exemption and will tag any that have PTR and are either 200% or the median or more than \$400,000, whichever is greater. (You **do not** need to send in the Detail report, just the 2 Summary reports.)

Submit both the PTR list and the one page summary to Pam Waters.

Please make sure you run with 200% and \$400,000. If you last ran the program using the 150%, it may still be there. **Update to 200%.**

Ask for 3 copies of this report – one to keep, one to send to the STC, and one to give to the Treasurer for use during the Tax Drive. Convert the spooled PMB016 report to a PDF. See instructions: "Convert AS400 Spool File to PDF". Counties Technical Tips | Idaho State Tax Commission The signature page on the PMB016 still needs to be printed and signed by the Assessor.

\*\*If you ran your PMB016 and submitted it to the STC **prior** to running this checklist, please rerun it and verify that the values are still the same.

#### 52. **NEW CONSTRUCTION ROLL**

As per Section 63-301A, Idaho Code, the New Construction Roll must be certified to the County Auditor by the **1ST MONDAY IN JUNE.** Do <u>not</u> send a copy to the State Tax Commission at this time. The PMB106 sent to the STC at Abstract time will fulfill the STC requirement for New Construction.

The passage of HB645 (retroactive to 1/1/2010) requires that you report losses in value on any prior new construction rolls. There are 3 triggers: In accordance with § 63-301A(1)(f) Idaho Code and Rule 802: 1) a BTA or Court decision; 2) an error such as a double assessment; or 3) a value decrease due to a change in **land** use classification that result in a **value decrease** of a parcel **that has been previously included on any New Construction Roll**, then the amount of the **difference between the value first reported on any New Construction Roll and the current value shall be deducted from this year's New Construction Roll**.

To help you track and report this loss of value, we have a market adjustment field (NC) in Parcel Master. PMB250, PMB251 and PMB256 will also reflect the addition of this adjustment. See the instructions entitled **"New Construction Adjustment Entry/Update Process"**. <u>Counties Technical Tips | Idaho State Tax Commission</u>

\*\*HB389 (passed 5/6/21) no longer allows you to claim New Construction value for change of use on land categories, whether it has a new structure on it or not.

The following reports will satisfy the county requirements:

- A. Enter any loss in New Construction value. (see above)
   PMO254 Will allow you to look up old new construction records by parcel.
   PMB260 Will List All NC Adjustment Records.
- B. PMB250 New Construction by Taxing District

Run in **Summary** to get net taxable new construction value by taxing district.

C. PMB254 - List/Delete Incomplete UANEWC00 Records

Execute this program the first time without update using the year 2025. Check these over to see if records need updating or if they can be deleted. When ready, rerun the program in update; those with incomplete records will be deleted.

- D. PMB256 New Construction Detail Listing The New Construction Roll (detail) shall be certified to the County Auditor no later than the first Monday in June. The market value on the PMB256 should balance to the net market value on the PMB250.
- E. PMB251 New Construction Abstract

The new construction value on this report should balance to the NET MARKET value on the PMB250. (This abstract is not a requirement but will give you an additional

balancing report.) Submit this report to your County Clerk by the 1<sup>st</sup> Monday of June. You do **not** need to send it to Ben Seloske.

Any adjustments or corrections to the New Construction Roll must be done prior to the **1st Monday of August.** 

53. **PMB525 State HO Database File.** This will produce a report (for you, if requested) and a file (HOTable) that will be used to update the statewide HO database. The database is on the STC website; use the same sign on as used to order forms. **Please run in Detail**. It will produce a file (**HOTable**) which we need you to send to our SFTP site (see PMB525 instructions and the Instructions to Send to HO File to STC emailed to you.) <u>Counties Technical Tips | Idaho State Tax Commission</u> (PMB525 Download Instructions)

- 54. **Annexation Records**. Remember to start creating your Annexation records so that they will be ready for your Abstract Checklist in July. (Create the record by using the net market value by cat for the district being annexed. Once a record is created, it will be picked up and reported on the Abstract reports.) See the **Annexation Checklist** on our website: <u>Counties Technical Tips | Idaho State Tax Commission</u>
