**"CORRECTED" ORDER

IT IS HEREBY ORDERED, as approved by the Board of Commissioners of the Upper Deer Flat Fire Protection District, a governmental subdivision of Canyon County, State of Idaho, the following described real property shall become a part of the **UPPER DEER FLAT FIRE PROTECTION DISTRICT**: The lands owned by **Canyon County at the Pickles Butte Sanitary Landfill** are described as follows:

S $\frac{1}{2}$ SW $\frac{1}{4}$; SE $\frac{1}{4}$; SE $\frac{1}{4}$ NE $\frac{1}{4}$; S $\frac{1}{2}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$; NW $\frac{1}{4}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$; and the E 560 feet W $\frac{1}{2}$ NE $\frac{1}{4}$ lying South of the Deer Flat Road; Section 20, Township 2 North, Range 3 West, Boise Meridian, approximately 343.64 acres.



Dear Mr. Shroll:

The Board of Canyon County Commissioners would like to petition for annexation of a portion of the property owned by the County at the Pickles Butte Sanitary Landfill into the Upper Deer Flat Fire District. The County has complete our purchase of lands adjacent to the landfill from the BLM. The County owns approximately 1384 acres at the landfill of which about 524 is currently in the Upper Deer Flat District. We request that the Fire District annex an additional 860 acres of County owned property into the District.

This currently owned property is contiguous with the Upper Deer Flat Fire District boundary and is therefore applicable for annexation in conformance with the provisions of 31-1411 Idaho Code.

Please find attached a legal description and map of the entire property owned by the County which includes the 860 acres we are requesting for annexation.


