The Order of Annexation received by the Board appearing in all respects to be in compliance with the provisions of Idaho Code §31-1411;



Certain Land Owners in Cassia County petitioned the Board of Commissioners for the annexation of certain lands in Cassia County that are adjacent to the boundary of the Albion Fire Protection District. The lands sought to be annexed are in Cassia County, Idaho and more particularly described on Exhibit A attached hereto and made a part hereof by reference.

Upon the filing of the Petition the Commissioners of the Albion Fire Protection District determined that the Petition contained the names of more than seventy-five percent (75%) of the owners or contract purchasers of the land sought to be annexed.

Pursuant to Idaho Code § 31-1411 a hearing was held on the Petition at the Albion Fire Department, 125 E. Market Street, Albion, ID 83311 on the 1st day of June 2009 at 7:00 p.m. Notice of the hearing was published in the Times News on May 15, 2009.

The Commissioners find that it is in the best interest of the Albion Fire Protection District and the person whose land is sought to be annexed and, therefore, it is **ORDERED**:


1. The Petition for Annexation of the land described on Exhibit A attached to this Order is in all respects approved.
