AN ORDINANCE OF THE CITY OF MOUNTAIN HOME, IDAHO, DEANNEXING AND EXCLUDING CERTAIN REAL PROPERTY FROM THE CITY OF MOUNTAIN HOME, IDAHO, AS PERMITTED BY IDAHO CODE SECTION 50-225, AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF MOUNTAIN HOME, IDAHO:

SECTION 1. That the following described real property located in the City of Mountain Home, County of Elmore, State of Idaho, is hereby deannexed from the City of Mountain Home, Idaho, and excluded from the boundaries of the City of Mountain Home, Idaho, said property being described as follows:

The Southeast Quarter of the Southeast Quarter of Section 11, and the Southwest Quarter of the Southwest Quarter of Section 12, all in Township 4 South Range 6 East, Boise Meridian.

SECTION 2. That this ordinance shall be in full force and effect from and after its passage, approval and publication.






