ORDINANCE NO. 1525

AN ORDINANCE ANNEXING TO THE CITY OF MOUNTAIN HOME, IDAHO, THE REAL PROPERTY HEREINAFTER DESCRIBED AND DECLARING THE SAME, BY PROPER LEGAL DESCRIPTION THEREOF, TO BE A PART OF SAID CITY OF MOUNTAIN HOME, AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF MOUNTAIN HOME, IDAHO:

SECTION 1. That the following described real property is situated in the County of Elmore, State of Idaho, is contiguous and adjacent to the City of Mountain Home, Idaho, and the owner or owners of said property have requested in writing that the property be annexed to the City of Mountain Home, Idaho, and said real property is hereby annexed to and made a part of said City of Mountain Home, Idaho, and is described as follows:

Commencing at the section corner common to Sections 26, 27, 34 and 35, Township 3 South, Range 6 East, Boise Meridian, Elmore County, Idaho, thence North 0°29' East 38.50 feet to a point; thence South 89°31' East 30.00 feet to a point; thence North 0°12' East 290.00 feet along the County Road right-of-way to the Real Point of Beginning; thence South 89°31' East 208.70 feet to a point; thence North 0°12' East 208.70 feet to a point; thence North 89°31' West 208.70 feet to a point; thence South 0°12' West 208.70 feet to the Real Point of Beginning.

SECTION 2. That said real property is contiguous and adjacent to the City of Mountain Home, Idaho, and said real property is hereby declared to be a part of said City.

SECTION 3. That this ordinance shall be in full force and effect from and after its passage, approval and publication.




