RIMROCK FOREST ESTATES ANNEXATION

THE BOARD OF DIRECTORS (the "Board") OF NORTH KOOTENAI DISTRICT (the "District") makes the following findings relative to Resolution No. 2009-18, canvassing the special election conducted on May 26, 2009, to annex the Rimrock Forest Estates area into the District, presented to the Board:

(1) The District is a validly formed water district under and by virtues of the laws of the State of Idaho.

(2) The owners of certain real property located in Kootenai County, Idaho, generally adjacent to the boundaries of the District, affirmed at a special election to annex the Rimrock Forest Estates area into the District which complied with the requirements of Idaho Code §42-3218(a) (a copy of Resolution No. 2009-18 is attached hereto as Exhibit "A" as though fully set forth herein).

(3) The Board of Directors has examined the returns of the election on the proposition and has found that a majority of the qualified electors of the District voting at such election cast their votes in the affirmative for the proposition. (The area covered by the annexation is set forth in the map attached hereto and incorporated herein by this reference as Exhibit "B".)

(4) The Board, after consideration of the records and files herein and the public health and safety of the current and future residents and businesses in the District and the area proposed for annexation, find it in the best interests of the District, its residents and those who are in the area to be annexed into the District, to annex the area covered by Resolution No. 2009-18.

(5) Subject to the conditions placed on the annexation by the District, the real property described in the map attached hereto as Exhibit "B" and legally described in Exhibit "C" attached hereto is hereby incorporated into the District as of the date this Order is filed with the County Recorder.
