**ORDINANCE REGARDING THE
VOLUNTARY ANNEXATION OF PROPERTY BELONGING TO
TRAVIS KEITHLY
INTO THE CITY LIMITS OF
THE CITY OF MIDVALE, IDAHO**

WHEREAS, the City of Midvale, Idaho, has been requested by TRAVIS KEITHLY to annex certain real property belonging to said TRAVIS KEITHLY into the city limits of the City of Midvale, Idaho,

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MIDVALE, IDAHO, that the following described property shall be annexed into the city limits of the City of Midvale, Idaho and placed on the city tax rolls:

Washington County, Idaho:

Commencing at the Southeast corner of the NW1/4SE1/4 of Section 8, Township 13 North, Range 3 West of the Boise Meridian, Washington County, Idaho:

Thence North 990 feet more or less, to a point 330 feet South of the Northeast corner of said NW1/4SE1/4, the point and place of beginning.

Thence West parallel to the North line of said subdivision to a point on the West line of said NW1/4SE1/4;

Thence South 400 feet, more or less to the North boundary of an existing irrigation ditch;

Thence Easterly along the North boundary of said irrigation ditch to a point on the East line of said NW1/4SE1/4;

Thence North along the East line of said NW1/4SE1/4 to the point and place of beginning.



The S1/2SW1/4SE1/4 of Section 8, Township 13 North, Range 3 West of the Boise Meridian, Washington County, Idaho: Save and Except the following described tract:

Beginning at the Southwest corner of the S1/2SW1/4SE1/4 of said Section 8;
Thence East along the South line of said S1/2SW1/4SE1/4 a distance of 750 feet;
Thence North parallel to the West line of said S1/2SW1/4SE1/4 a distance of 370 feet;
Thence West parallel to the South line of said S1/2SW1/4SE1/4 a distance of 750 feet more to less to a point on the West line of the said S1/2SW1/4SE1/4;
Thence South along the West line of said S1/2SW1/4SE1/4 a distance of 370 feet, more or less to the point of beginning.

This ordinance shall be effective upon the publication of such ordinance.


