Lakeland Joint School District No. 132 ("Lakeland") having filed with the State Board of Education ("Board"), pursuant to Section 33-307, Idaho Code, a Petition for modification of the Board's Order of October 28, 2008, in order to correct errors in the legal description of the Lakeland's boundaries and those of West Bonner School District No. 83 ("West Bonner");

2. West Bonner having submitted to the Board its Statement of Acquiescence in Lakeland's Petition;

3. The Board at its meeting of April 2010, having reviewed and considered Lakeland's Petition and the supporting documents submitted by Lakeland and West Bonner, and, there being good cause, having approved at its meeting a motion to approve the correction of the legal description of boundaries from West Bonner to Lakeland as requested in Lakeland's Petition;

NOW, THEREFORE, the State Superintendent of Public Instruction, pursuant to Section 33-307(1), Idaho Code, hereby Orders, and this does Order, effective as of April 22, 2010, as follows:

That the following property be excised from West Bonner County School District No. 83 and annexed to Lakeland Joint School District No. 272:

All of those parcels of land located in Township 54 North, Range 4 West, Boise Meridian,

1. Section 29: All those parcels of land located in Section 29 described as follows:

The south one-half;

The south one-half of the southeast quarter of the northeast quarter;

The southwest quarter of the northeast quarter;

The south one-half of the northwest quarter;

The south one-half of the south one-half of the northwest quarter of the northwest quarter;


2. Section 30: All those parcels of land located in the northeast quarter of Section 30, EXCEPT the north one-half of the north one-half of said Northeast quarter;

3. Section 31: All those parcels of land located in the east one-half of said section lying east of Idaho State Highway 41 and southeasterly of Spirit Lake Cutoff Road; together with the south one-half of the south one-half of the southeast quarter.

4. Section 32: All those parcels lying within Section 32.

It is further ordered that the above legal description supersedes the legal descriptions contained in the Board's Orders of June 25, 2008 and October 28, 2008.
