BEGINNING at the NE corner of the SE 1/4 of Sec. 1, Twp. 5 N, R 4 WBM; thence south 3 & 1/2 miles to the SE corner of Sec. 24; thence continuing south along the section line to the north side of the county road in the NW 1/4 NW 1/4 of Sec. 30, Twp. 5 N, R 3 WBM; thence following the county road in a northeasterly direction to the east boundary of the NW 1/4 NW 1/4 of Sec. 30; thence north to the NW corner of the SE 1/4 SW 1/4 of Sec. 19, Twp. 5 N, R 3 WBM; thence east to the NE corner of the SE 1/4 SW 1/4 of Sec. 19; thence south to the SE corner of the SE 1/4 SW 1/4 of Sec. 19; thence east 1 mile to the south 1/4 corner of Sec. 20, Twp. 5 N, R 3 WBM; thence south 3 & 1/4 miles to the SE corner of the NE 1/4 NW 1/4 of Sec. 8, Twp. 4 N, R 3 WBM; thence 1/4 mile east; thence south 1 & 3/4 miles to the south bank of the Boise River; thence northwesterly along the Boise River to the NW corner of Lot 2, Sec. 3, Twp. 4 N, R 4 WBM; thence south 2 & 1/2 miles to the middle of Sec. 15, and the intersection of the Riverside Canal; thence northwesterly along the Riverside Canal to the west section line of Sec. 16, Twp. 4 N, R 4 WBM; thence north 1/4 mile to the SW corner of Sec. 9; thence 3/4 mile west; thence north 1/4 mile to the Riverside Canal; thence north-westerly along the Riverside Canal to the west line of Sec. 8, Twp. 4 N, R 4 WBM; thence west to the center of Sec. 7; thence north to the Riverside Canal; **thence northwesterly along the Riverside Canal to the west boundary of Sec. 6, Twp. 4 N, R 4 WBM;** thence north to the NW corner of the SW 1/4 NW 1/4 of Sec 6; thence west 1 mile to the SW corner of Lot 4 of Sec. 1, Twp. 4 N, R 5 WBM; thence north 1/4 mile to the township line; thence east 1/4 mile; thence north 1/4 mile; thence east 1/4 mile; thence north 1/2 mile; thence west 1/4 mile; thence north 1/4 mile to the south bank of the Boise River; thence southeasterly along the Boise River to the NW corner of Lot 7 of Sec. 33, Twp. 5 N, R 4 WBM; thence north 4 & 1/2 miles, more or less, to the Payette-Canyon County line; thence east along the Payette-Canyon County line 1 & 3/4 miles to the NW corner of Sec. 11, Twp. 5 N, R 4 WBM; thence north 1/2 mile; thence east 2 miles to the point of beginning.
