ORDER OF DE-ANNEXATION

WHEREAS, it appears that a certain area of property described herewith below was originally part of the Orofino Rural Fire District.

WHEREAS, a Petition requesting Withdrawal of this property herewith below described from Orofino Rural Fire District was filed with the Clearwater County Clerk of the Board of Commissioners. Said petition reads as follows: The undersigned petition(s) the Clearwater County Commissioners to be de-annexed from the Orofino Rural Fire District boundaries as described in Executive Order 214585 of Annexation into Sunnyside Rural Fire District. This de-annexed portion of the Orofino Rural Fire District will continue to have fire protection by the Sunnyside Rural Fire District.

WHEREAS, on the 1st day of May, 2010, the Sunnyside Rural Fire District did grant petitions for the annexation of additional real property in Clearwater County, State of Idaho, to be included in the Sunnyside Rural Fire District boundaries; and

WHEREAS, the petitions for de-annexation contain the real property from the current Orofino Rural Fire District Boundary, and the Orofino Rural Fire District did grant de-annexation of said petitioner's real property as they will still receive fire protection; and

WHEREAS, the appropriate notice of hearing was duly published in the Clearwater Tribune, Orofino, Idaho on April 22, 2010; and May 13, 2010; and

WHEREAS, it appears to the Board of County Commissioners that all matters precedent to said de-annexation have been complied with as per Idaho Code 31-1411; and

NOW THEREFORE, the Board of County Commissioners of Clearwater County hereby orders that the following described areas containing real property be de-annexed from the Orofino Rural Fire District, and the same be replaced upon the tax rolls of Clearwater County, State of Idaho, as being within the boundary of the Sunnyside Rural Fire District.

Described areas are located within a portion of Section 32, Township 37 North, Range 1 East, Boise Meridian; County of Clearwater, State of Idaho, more particularly described as:

The Southwest Quarter of Northeast Quarter (SWNE) West of the county road (Cavendish Grade) and the South 462 feet of the Northwest Quarter of the Northeast Quarter (NWNE).

IT IS FURTHER ORDERED AND IT IS HEREBY MADE AS THE DUTY OF, the Clerk of this Board, is hereby directed to cause a duly certified copy of this order to be transmitted to the Clearwater County Assessor and to the Idaho State Tax Commission.



Sunnyside Fire Sutton Annexation




