**ORDER OF ANNEXATION
TO THE SUNNYSIDE RURAL FIRE DISTRICT**

Return to Clearwater County

WHEREAS, on the 1st day of May, 2010, the Sunnyside Rural Fire District did grant petitions for the annexation of additional real property in Clearwater County, State of Idaho, to be included in the Sunnyside Rural Fire District boundaries; and

WHEREAS, the petitions for annexation contain the real property from the current Orofino Rural Fire District Boundary, and the Orofino Rural Fire District did grant de-annexation of said petitioner's real property; and

WHEREAS, the appropriate notice of hearing was duly published in the Clearwater Tribune, Orofino, Idaho on April 22, 2010; and May 13, 2010; and

WHEREAS, it appears to the Board of County Commissioners that all matters precedent to said annexation have been complied with as per Idaho Code 31-1411; and

NOW THEREFORE, the Board of County Commissioners of Clearwater County hereby orders that the following described areas containing real property be annexed to the Sunnyside Rural Fire District and that the same be placed upon the tax rolls of Clearwater County, State of Idaho, as being within the boundary of the Sunnyside Rural Fire District.

Described areas are located within a portion of Section 32, Township 37 North, Range 1 East, Boise Meridian; County of Clearwater, State of Idaho, more particularly described as:

The Southwest Quarter of Northeast Quarter (SWNE) West of the county road (Cavendish Grade) and the South 462 feet of the Northwest Quarter of the Northeast Quarter (NWNE).

NOW, THEREFORE, the Board of County Commissioners, Clearwater County, hereby grants the petition and accordingly affixes the proposed boundaries as set forth in said petition.

A portion of land located in Section 32, Township 37 North, Range 1 East, Boise Meridian, County of Clearwater, State of Idaho more particularly described as:




