CERTAIN PROPERTY INTO THE GRANGEVILLE)
RURAL FIRE PROTECTION DISTRICT)

ORDER

A petition has been filed by James and Nadine McDonald to have their land, described as follows: Township 30 North, Range 2 East, Boise Meridian, Idaho County, Idaho, Section 2: A parcel of land located in the SE4SE4 sometimes known as Assessor's Tax Number 140 and the portion of land that is East of and adjacent to Assessor's Tax Number 140 and West of the East line of section 2, being a portion of Old Highway 7, more particularly described as follows:

Beginning at the Southeast section corner of Section 2, Township 30 North, Range 2 East, Boise Meridian, a brass cap monument in place, the TRUE POINT OF BEGINNING: thence South 89°42' West, on the South section line of Section 2, 60 feet to the West right of way line of a county road; thence along the South section line of Section 2, South 89°42' West, 395 feet; thence North 00°08' East, 1315.14 feet; thence North 89°42' East, 415.00 feet to the West right of way line of a county road; thence North 89°42' East 60 feet to the East section line of Section 2; thence South 01°00'15" West 1315.70 feet along the East section line of Section 2 to the TRUE POINT OF BEGINNING.

The Public Hearing was held on June 16, 2011, at which time the Fire Protection District Commissioners entertained public comment and after having given full consideration to the matter, unanimously approved the petition; and

The Board of Commissioners of Grangeville Rural Fire Protection District has certified the results of said hearing to the form of an Order containing the above described property to be annexed into the Grangeville Rural Fire Protection District and has forwarded said order to the County Commissioners of Idaho County; and

Further, it appears that the Grangeville Rural Fire Protection District has complied with all requirements of the law for annexation of the described real property.

NOW, THEREFORE, IT IS HEREBY ORDERED that the annexation petition by James and Nadine McDonald be hereby granted.

IT IS FURTHER ORDERED that the boundaries of the Grangeville Rural Fire Protection District be amended so as to include the real property which is described above.




