2. Petitioner and her successors shall abide by the lawful rules, agreements, regulations, policies, and requirements of the District now in force and hereafter adopted.



4. A certified copy of this Order Granting Inclusion Within Water District shall be filed of record with the recorder's office of Kootenai County, state of Idaho.






