
boundary of the District as allowed by Idaho Code section 43-3218(a).

2. Petitioners and their successors shall abide by the lawful rules, agreements, regulations, policies, and requirements of the District now in force and hereafter adopted.




4. A certified copy of this Order Granting Annexation shall be filed of record with the recorder's office of Kootenai County, state of Idaho.




