ORDER OF ANNEXATION

This matter having come before the Bonner County Board of Commissioners during a regularly scheduled business meeting on the 24th day of January, 2012 with regard to a request by the West Pend Oreille Fire District to approve an annexation of a parcel of property into their district.

THE BOARD HEREBY ORDERS AS FOLLOWS:

WHEREAS, a Petition for Annexation was filed by residents of a parcel of property, hereinafter known as the Langille Canyon Annexation, located outside the boundaries of the West Pend Oreille Fire District;

WHEREAS, said property is located entirely within Bonner County, Idaho;

WHEREAS, the Board of Commissioners of West Pend Oreille Fire District, on the 20th day of December, 2011, held public hearing regarding this annexation;

WHEREAS, after that public hearing the West Pend Oreille Fire District's Commissioners signed an Order of Annexation for said property;

WHEREAS, a certified copy of that Order is attached and incorporated herewith;

WHEREAS, an accurate legal description is provided in the West Pend Oreille Fire District's Order of Annexation;

NOW, THEREFORE, IT IS HEREBY ORDERED that the subject property described as Langille Canyon Annexation is annexed into the West Pend Oreille Fire

District. This Order shall be recorded and the annexed property shall be included on the tax roles pursuant to Idaho Code, Title 31, Chapter 14.


WHEREAS, it appears in the best interest of the West Pend Oreille Fire District and the parties petitioning for inclusion therein, that annexation be sought, and,

WHEREAS, pursuant to the meeting held for the purposes of considering the same and there being no one opposed, and upon unanimous approval of the commissioners;





Beginning at a point on the Washington-Idaho State Line approximately 300 feet north of the Le Clerk Creek-Langille Canyon (Freeman Lake) Road intersection located in the NE1/4, SW1/4 of Section 13, T56N, R6W; Boise Meridian; thence northeasterly on a line paralleling and 300 feet north of the centerline of said Langille Canyon Road to the east line of the W1/2, SW1/4, NE1/4 of Section 13, T56N, R6W; thence north to the NE corner of the W1/2, SW1/4, NE1/4 of Section 13, T56N, R6W; thence north 150 of W1/2 NWNE; thence west to the West line of NE1/4; thence north to the NW corner NE1/4 Section 13, T56N, R6W; thence west to the NW corner of Lot 1, Section 13, T56N, R6W, said point being on the Washington-Idaho State Line; thence south to the Point of Beginning, all in Bonner County, Idaho.
