
Further, it appears that the Kootenai County Fire & Rescue District has complied with all requirements of the law for annexation of the described real property;

NOW, THEREFORE, IT IS HEREBY ORDERED that the annexation petitioned for by the owners be and hereby is granted.



ORDER

On the 13th day of August 2012, at 6:00 pm, the Kootenai County Fire & Rescue District's Board of Commissioners conducted a Public Hearing, after duly advertising and conforming to the requirements of Idaho Code 31-1411, to consider two (2) Petitions of a certain property located within the County of Kootenai, to annex real property into the Kootenai County Fire & Rescue District.

The property owners requesting Annexation into the Fire District are: (1) *Petitioners Kevin & Michelle Rogers*, located at 2338 S. Big Rock Road in Post Falls, for approx. 9.9510 acres that are contiguous to existing Fire District boundaries. The property's legal description is Gov't Lot 3, Parcel 2700, Section 30, Township 50 North, Range 05 West, Boise Meridian, Kootenai County, Idaho. (2) *Petitioners Daniel & Heather Tolleson*, located at 3364 S. Alexanna Lane in Post Falls, for approx. 10.0550 acres that are contiguous to existing Fire District boundaries. The property's legal description is Parcel 9800, Section 25, Township 50 North, Range 06 West, Boise Meridian, Kootenai County, Idaho. The land sought to be annexed is located in Kootenai County, Idaho, and more particularly described on "Petition for Annexation" attached hereto, and by this reference incorporated herein.

The Kootenai County Fire & Rescue District's Board of Commissioners reviewed the "Petition for Annexation," which was found to be conforming with respect to Idaho Code Section 31-1411, entertained public comments at said hearing, and after having given full consideration to the matter, unanimously approved the presented "Petitions for Annexation".







KOOTENAI COUNTY FIRE & RESCUE MEETING OF THE COMMISSIONERS

August 13, 2012

The Kootenai County Fire and Rescue Board of Commissioners met in regular session at KCFR Station #1 located at 404 N. Idaho Street in Post Falls, on Monday, August 13, 2012.

CALL TO ORDER: The meeting was called to order by President Keith Hutcheson at 1800 hours.

PLEDGE OF ALLEGIANCE: The Pledge of Allegiance was led by Reserve Ben Deon.

ROLL CALL OF THE BOARD OF COMMISSIONERS: Commissioners Keith Hutcheson, Joe Doellefeld, Richard Nordstrom, and Paul Wagner were present. *Others present:* Chief Warren Merritt, Deputy Chief Aaron Jones, Division Chief Dan Ryan, Division Chief Tam Barrett, Division Chief Heath Sheppard, EMS Coordinator Bill Keeley, Logistics Manager Todd English, Director of Administration Samantha Babich, District Bookkeeper Jessie Morrow, and District Secretary Laurie Perkinson. *Guests:* (See attached list) ten (10) members of Kootenai County Fire & Rescue and one (1) guest: Chris Holloway, North Idaho Fairgrounds.

1. ANNOUNCEMENTS, PRESENTATIONS, CEREMONIES:

2. AMENDMENT TO THE AGENDA:

Move item B. North Idaho Fair Fee Waiver under New Business to directly after the Consent Calendar.

3. DECLARATION OF CONFLICT:

President Hutcheson declared a conflict for the Public Hearing, Kevin & Michelle Rogers are personally known to him.

4. CONSENT CALENDAR:

A. Commissioner Doellefeld made a motion to approve the Consent Calendar, which includes the Monthly Commissioner's Meeting Minutes for July 9, 2012 and the Special Commissioner's Meeting on August 6, 2012; as presented excluding the Administration report from the Officers Reports. Commissioner Wagner seconded the motion. Motion carried.

B. Commissioner Doellefeld made a motion to approve the Administration report from the Officers Reports, as presented. Commissioner Wagner seconded the motion. Motion carried.

5. NEW BUSINESS:

B. North Idaho Fair Fee Waiver:

Commissioner Doellefeld made a motion to waive the fees for the North Idaho Fair's request for standby for all fees associated with Kootenai County Fire & Rescue. Commissioner Nordstrom seconded the motion. Motion carried.

6. PUBLIC HEARING:

Commissioner Nordstrom made a motion to exit the regular meeting and go into a public hearing. Commissioner Wagner seconded the motion. Motion carried. Commissioner Hutcheson asked if there were any public comments for or against the annexations of the Kevin and Michelle Rogers property or the Daniel and Heather Tolleson property. Hearing none he asked to close the Public Hearing.

Commissioner Nordstrom made a motion to close the Public Hearing and enter into the regular session. Commissioner Wagner seconded the motion. Motion carried

7. UNFINISHED OLD/BUSINESS:

A. Petition for Annexation – Kevin & Michelle Rogers:

Commissioner Nordstrom made a motion to approve the Petition for Annexation for Kevin and Michelle Rogers, located at 2338 S. Big Rock Road in Post Falls. Commissioner Wagner seconded the motion. Motion carried.

B. Petition for Annexation – Daniel & Heather Tolleson:

Commissioner Nordstrom made a motion to approve the Petition for Annexation for Daniel and Heather Tolleson, located at 3364 S. Alexanna Lane in Post Falls. Commissioner Wagner seconded the motion. Motion carried.

C. New Administration Building Update:

D. Maintenance/Training Building Update:

Commissioner Doellefeld made a motion to authorize the Chief Officer to enter into a contract with Interstate Asphalt to complete the training tower paving as described in the bid, not to exceed \$36,000. Commissioner Nordstrom seconded the motion. Motion carried.

A. The Board directed staff to arrange for the Advisory Board to meet and come up with a plan on what direction we should go with this new information.

B. The Board directed staff to draft a positive, informative letter to the City of Post Falls Council members and explain our situation.

F. MOU for False Alarms at Arrow Point Update:

The Board directed staff to table this item until East Side Fire takes the changes of adding in "Nuisance calls" to their fee schedule to their Board. After they make their changes, we will discuss making ours.

G. Surplus Equipment Update:

H. Surplus Apparatus Disposition Update:

Commissioner Doellefeld made a motion to surplus vehicles V-23, V-09, V-55, and P-48; put out to bid; set a minimum bid; set a bid due by date; open up for sealed bids; and advertise with other agencies and to the public. Commissioner Nordstrom seconded the motion. Motion carried.

I. WUI Maintenance Inspections Update:

J. Station #1 Paving Work Update:

The Board directed staff to start getting bids while we are waiting for Strata to come up with their recommendation. Ask the paving companies for two separate bids; A) putting another layer of asphalt down, and B) grinding it and repaving it. Come back to the Board with a recommendation after Strata's inspection and receiving the bids.

We truly believe our guys are professional and would never, ever compromise themselves in that aspect. Also, write a letter responding back to Commissioner Tondee.


The Board of Commissioners exited Executive Session and resumed the Regular Session at 2005 hours.


