**MINUTES OF THE MEETING OF THE BOARD OF COMMISSIONERS
BONNEVILLE COUNTY/IDAHO**

Monday, July 11, 2016

IN THE MATTER OF ADMINISTRATIVE ISSUES:

Commissioner/Chairman Roger Christensen, Commissioner Lee Staker and Commissioner Dave Radford met to consider various administrative items, including contracts, agreements, routine tax cancellations, personnel action forms and other general administrative items as needed.

AUTHORIZATION OF SCHOOL TUITION AID: In accordance with Idaho Code, the Commissioners verified residency of Ruby Lemus Belman for fall 2016 and spring 2017 and Maxine Johnson for fall 2016, allowing tuition aid from Bonneville County for the College of Southern Idaho.

IN THE MATTER OF DISSOLUTION OF ROBERT KETTLEBUTTE WATERSHED MEETING:

Commissioner Christensen and Commissioner Radford met to dissolve Robert Kettle Butte Watershed pursuant to Idaho Code 2-3717 Commissioner Radford moved to dissolve this watershed and Commissioner Christensen seconded the motion in the absence of Commissioner Staker. Resolution # 10-12 passed but was not valid. The law has since changed and now longer requires a hearing.

IN THE MATTER OF BOARD OF EQUALIZATION FOR HOMEOWNERS EXEMPTION RECOVERY:

The Board of Commissioners assembled as a Board of Equalization as provided for in Idaho Code with Commissioner/Chairman Christensen and Commissioner Radford were present. Also present was Chantell Tolman. The following protests were heard and acted upon on this date:
