RE: Special District Dissolution, North Rockford Bay Sewer District

The Idaho Local Governing Entities Central Registry was established in 2014 by statute §67-450E. The purpose of the registry is to maintain a complete list of administrative and financial information for all local governing entities in the state. All special districts in Kootenai County have been properly notified of the requirements of the statute.

North Rockford Bay Sewer District is shown as active per the Idaho State Tax Commission (STC), however, there is no contact information for this district with the state. Per discussion with Alan Dornfest of the STC on September 22, 2016, Kootenai County should determine if there are any assets or outstanding liabilities for this district before taking steps to dissolve.

Kootenai County has records dating back 20 years as the most current for this district. The Assessor's office finds no activity for this district. The Auditor's office has researched this district and cannot find any contact information, property definition, assets, liabilities, or evidence of activity.

After full legal review, it is the recommendation of the Auditor's office to dissolve this district under the guidance of statutes §63-4104 and 4105.

NOW THEREFORE, IT IS RESOLVED that the North Rockford Bay Sewer District be and hereby is, dissolved effective November 15, 2016.




