

RESOLUTION NO. 2021-03
ST. MARIES FIRE PROTECTION DISTRICT
(AKA ST. MARIES RURAL FIRE PROTECTION DISTRICT)
RESOLUTION PROVIDING FOR CHANGE OF NAME OF THE DISTRICT

WHEREAS, Idaho Code §67-2321 provides that the governing body of any taxing district within the State of Idaho may, by a majority vote of its members, adopt a proposal to change the name for said district; and

WHEREAS, Idaho Code §67-2321 further provides that in order to consider a change of name, the taxing district must conduct at least one public hearing on such proposal, after giving at least fifteen days' prior notice of the date and time of such hearing in the official newspaper of the district; and

WHEREAS, Idaho Code §67-2321 further provides that, at the hearing, if it appears to the governing body that no good cause exists to deny the proposed change of name, the governing body may adopt a resolution effecting the name change, in the same form as was presented in the proposal on which the hearing was conducted; and

WHEREAS, if a petition signed by no less than ten percent of the qualified electors of the taxing district is presented in opposition to the proposed name change, the governing body of the taxing district shall submit the question to the electors of the district in accordance with the provisions of Chapter 14, Title 34, Idaho Code; and

WHEREAS, on April 10, 2001, the Commissioner of the St. Maries Rural Fire Protection District conducted a hearing on a proposal to change the name of the district to the St. Maries Fire Protection District (the District), in accordance with Idaho Code §67-2321, after having provided at least fifteen days' notice of said hearing in the St. Maries Gazette Record, the official newspaper of the District, and having found there to be no opposition to the change of

name, either at said meeting or by way of petition, and good cause appearing therefor, voted unanimously to change the name of the District to the St. Maries Fire Protection District, and to file their resolution to this effect with the Idaho State Tax Commission and Benewah and Kootenai Counties; and,

WHEREAS, the District has conducted its business and affairs as the St. Maries Fire Protection District since the change of name on April 10, 2001; and

WHEREAS, due to an error in providing the notifications provided by statute, the District failed to file its resolution of the change of name with either the Idaho State Tax Commission, or with Benewah and Kootenai Counties.

Now therefore, based upon motion made, seconded and unanimously carried, it was:

RESOLVED that the Commissioners of the District hereby ratify and approve of the action taken by the Board of Commissioners on April 10, 2001, renaming the District as the "St. Maries Fire Protection District," and further direct the Secretary of the District to take all steps and execute all documents necessary in order to effectuate the change of name that have not already been undertaken by the District, including filing a copy of this Resolution with the Idaho State Tax Commission and the recorder's office of Benewah and Kootenai Counties, Idaho, the counties in which the District is located, all as provided by Idaho Code §67-2321.



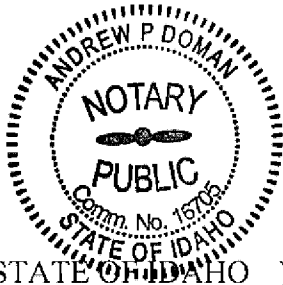

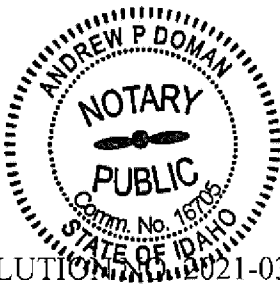
