The Surety agrees to pay taxes and any related penalties and interest if the business doesn't pay the taxes when they're due. (See chapter 13, title 23, Idaho Code.) The Tax Commission can recover from the Surety the tax and any related penalties and interest, up to \$\_\_\_\_\_.

The Surety reserves the right to withdraw as Surety and can withdraw by giving the Tax Commission written notice. The withdrawal becomes effective 30 days after the Tax Commission receives the notice. The withdrawal won't in any way affect the liability of the Surety to pay all taxes, penalties, and interest that the Principal owes or accrues before the end of the 30 days. This liability exists even if the Tax Commission doesn't issue an assessment for the owed or accrued tax, penalties, and interest until after the end of the 30 days. (See chapter 13, title 23, Idaho Code.)
