This program updates the other multipliers for mobile homes.

Apply or Remove must be specified.

20 Title is blank.
The multiplier description must be specified.

21 Factor is zeros.
The multiplier factor must be specified.

22 Class invalid.

Valid classes are 1 - 8.

23 Mar gra invalid.

Valid market grades are 1 - 5.

24 Widths invalid.

If 11 = N, you must specify to and from width.

EDITS:

- 01 Multiplier already exists on that parcel.
- 02 No multiplier positions left (maximum 7).
- 03 All appraisal information has been down loaded to a PC.

COMMENTS:

Other improvements are updated only if the main improvement use code was selected.

OUTPUT SUMMARY (or NA):

Parcel number, sheet, use code, review year, old description, old factor, new description, new factor, edits, manual selected, total parcels, total main improvements, total garages, total carports, total other improvements, prompt responses, and if run with or without updating.

SPECIAL CONSIDERATIONS:

When removing multipliers, the description and factor must match exactly.
