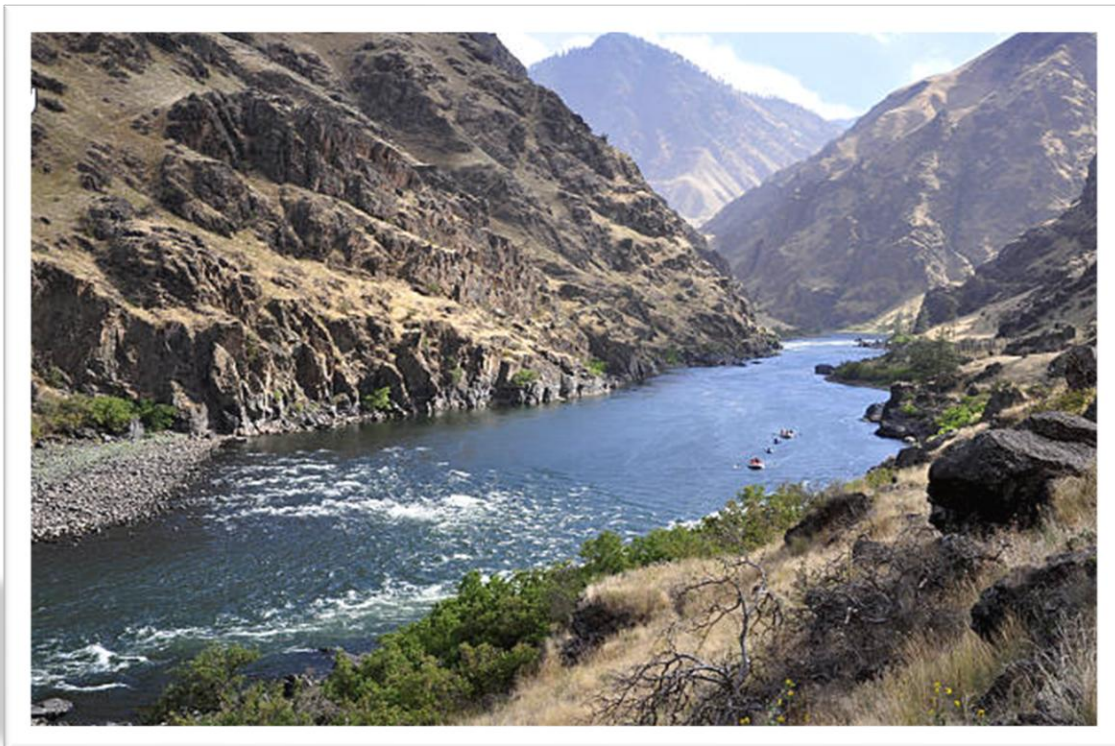

Dining

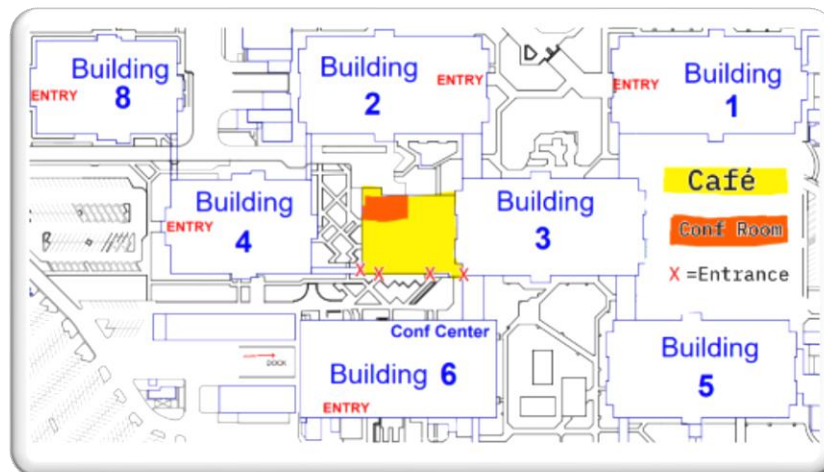
The Riverside Hotel has two restaurants. **There is no complimentary breakfast.**

The first Jaialdi was celebrated in 1987 at the historic Idaho State Penitentiary and was intended to celebrate the old and new, local and international aspects of Basque culture. More than 30,000 enthusiastic participants arrived and were treated to a parade, symposium, Mass, street dance, sports exhibitions, cultural performances, souvenir booths and food and drink.

In 1990, Idaho's then-governor, Cecil Andrus, requested that another Jaialdi be held as part of the 100th anniversary of Idaho's statehood. Jaialdi '90 took the same format, but with a few minor changes and improvements. It proved so popular, again, that organizers decided that Jaialdi would be a recurring festival that would happen every five years. Jaialdi is always held during the last weekend of July, which coincides with the Boise Basque community's celebration of San Ignatius de Loyola, the patron saint of the Basque people.

With upwards of 30,000 attendees at the last festival in 2015, Jaialdi is the largest Basque festival in the United States by far, and is larger than most Basque festivals in the world. Many Basques living in the Basque Country even make the trip to experience their own culture through the lens of the Basque-American diaspora.

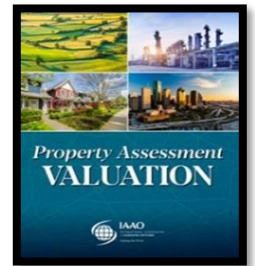

IAAO Course 101: Fundamentals of Real Property Appraisal

This course is designed to provide students with an understanding and working knowledge of the procedures and techniques required to estimate the market value of vacant and improved properties. This course focuses on the skills you need to estimate the market value of properties using two approaches to value: the cost approach and the sales comparison approach.

This course includes an optional exam. The exam is required for Idaho students using the course to meet state certification requirements. Please confirm with your jurisdiction about any additional exam requirements. Note that if pursuing an IAAO designation, successfully passing the exam is required.

Successful completion of this course meets one of Idaho's three requirements for becoming a "Certified Property Tax Appraiser" for ad valorem appraisal.

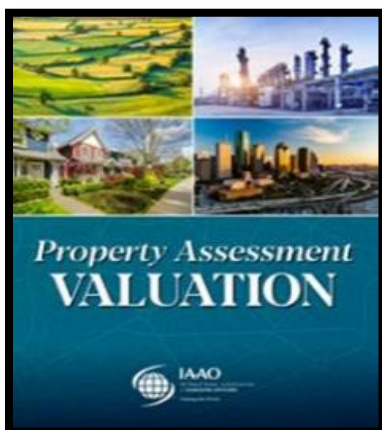

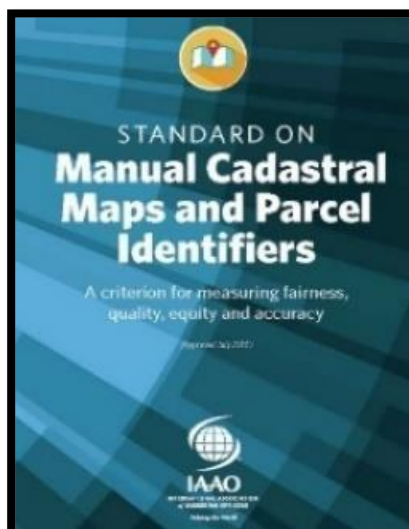

There is a brief, ungraded review that'll come with this workshop.

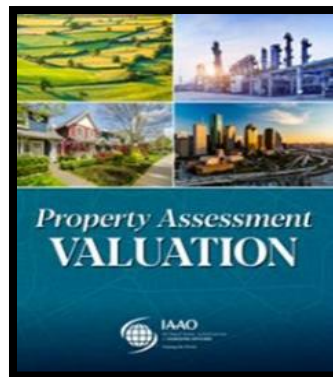

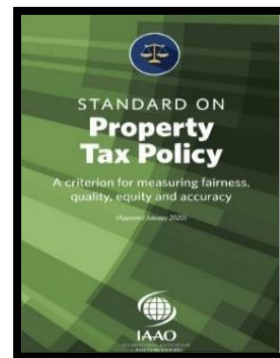


IAAO Workshop 403: Property Tax Policy Alternatives

Analysis

Words, Words, & Some Numbers: Ratio Studies in Action

This workshop will focus on the statistics used in sales ratio studies and how those can translate to the day-to-day life of an assessment office. Appraisers are taught how to calculate these statistics, but many do not know what should be done once they have them. This workshop demonstrates how a ratio study can help the assessor's office produce more accurate work and make the work process more efficient. It can also be an effective monitoring tool for employees' work quality, help confirm adjustments for established neighborhoods, and assist in creating new neighborhoods.

Students are encouraged to add their own examples as the class works together on typical challenges and scenarios that often occur in the assessor's office. Ratio studies can often seem like just some words, words, and a few numbers at first – a procedure required by oversight agencies. 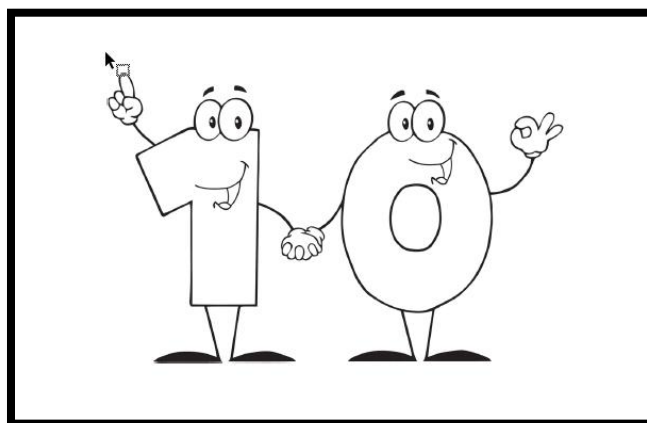

Valuation of Small, Income-Producing Properties
