STATE BOARD OF EQUALIZATION OPEN MEETING MINUTES OF MEETING HELD AUGUST 25, 2025

In attendance: Commissioners Paul Woods, Jeff McCray, Janet Moyle, and Jared Zwygart. Nathan Nielson and Christina Nelson, Deputies Attorney General. This meeting was open to the public and many guests attended online.

Commissioner Woods, Chairman for the State Board of Equalization, reconvened the State Board of Equalization for 2025 (Board) at 9:00 a.m. August 25, 2025.

The Board reviewed and considered for approval the Equalization of Centrally Assessed Values for 2025. Jerott Rudd, Property Tax Operating Property Bureau Chief, was recognized to present the operating property values for 2025. The Board was provided a spreadsheet listing all the operating property companies with the 2025 base value. From the base value, if there was a Railroad Revitalization and Regulatory Reform (4-R) Act reduction the company qualified for, it is listed in the "4-R Reduction" column. If there was an irrigation exemption, it is listed in the same-titled column. In the final column is the final 2025 values net of the 4-R reduction and the irrigation exemption. The total value for operating property, after making those adjustments is \$8,819,637,612. Mr. Rudd noted that the 4-R adjustments began in 2023, and in 2023, that adjustment was \$1.2 billion. In 2024, it went down to about \$684,000,000, and in 2025, the total 4-R reduction was \$125,000,000. The 4-R reduction has gone down over the three years they've done the 4-R analysis. Counties are doing a better job in the way the ratio study is currently done better reflects those that qualify for a 4-R reduction. Those are the values for 2025.

Commissioner Moyle said the counties are doing better, but she sees that some of the percentages are a little higher and she asked why. Mr. Rudd deferred to Alan Dornfest, Property Tax Policy Bureau Chief, to respond. Mr. Dornfest said the percentages may be higher, but they're not directly related to what the counties are doing. There are two different tests and they're studying two different years, so it's incidental. Counties are doing a better job, and he doesn't mean to imply otherwise: there were only five categories statewide out of compliance this year with the Rule 131 requirements. But meeting Rule 131 requirements doesn't mean anything with respect to the 4-R study. They use a weighting system, where high-value properties carry a very heavy weight; in the 4-R study, they don't, they do a parcel-based system for the general compliance rules. And secondly, and more importantly in many ways, they look at last year's values first and only in cases of non-compliance, and there were very few this year, so they don't know where the counties are with respect to 2025

values except by inference from the 2024 compliance situation. That isn't true for the averages in the 4-R study. The averages in the 4-R study are done strictly on the 2025 assessments. You can't compare the two. Commissioner Moyle said she appreciates the explanation, but it's disconcerted when she hears that something doesn't matter. How can they come up with an amount? Counties are doing better and she appreciates the work.

There was no further discussion. Commissioner Woods said the value for operating property is before the Board. Commissioner Zwygart moved to approve staff's recommendation for the 2025 Operating Property Values as presented. Ms. Young conducted a roll call vote. Commissioner McCray, aye; Commissioner Moyle, aye; Commissioner Zwygart, aye.

There was no further business to come before the Board, and Commissioner Woods adjourned the 2025 Board of Equalization.
