#### APPEALS RESOLUTION MEETING

February 15, 2023

Commissioner Katsilometes moved to uphold the Notice and update interest for Docket Number 1-218-484-224. Commissioner Zwygart seconded the motion. A roll call vote was taken by Commissioner McCray; all voted in favor and the motion was approved.

Commissioner Katsilometes asked a question regarding consequences of disclosing taxpayer information during an open meeting. Deputy Attorney General Phil Skinner answered that it is a felony.

Commissioner McCray corrected the Docket Number for action item j. The correct Docket Number, 1-218-484-224, was read into the record and Commissioner McCray stated that the decision and the vote would remain the same.
