HB 521	Representative Moyle, Representative Monks, Senator Ricks	Law	Taxation. This bill dedicates \$125 million in ongoing sales tax revenue to the new School Modernization Facilities Fund. This bill increases the funding of the School District Facilities Fund by increasing the sales tax revenue directed to the fund and increases lottery dividends to the fund. The total estimated property taxes of the homeowner property tax relief roll will utilize the immediate prior year's eligible levy rate in calculating the appropriate factor. Lastly, this bill reduces income tax rates.	July 1, 2024

This bill narrows the Administrative Procedure Act to restrict Temporary Rules, provides legislative oversight of materials incorporated into Admin. This legislation requires ballot language or official statements guaranteeing state tax relief funds to state when the funds will expire. Additionally, no ballot question or official statement shall include any information regarding state tax relief funds unless the dollar amount is specified and guaranteed.	July 1, 2024
<u>HB</u> 608aaS	Representative Andrus	Law	Agriculture Protection Areas. This bill replaces HB 473. This legislation adds a new chapter to the Idaho Local Land Use Planning Act which provides legislative authority for county governments to receive applications from willing landowners to establish a Ag Protection Area. HB 624	Representative Blanksma	Law	Special Assessment. This bill replaces HB 541. Local governments, lenders, and commercial building owners may enter the Commercial Property-Assessed Clean Energy (CPACE) financing structure to permit private commercial building owners to borrow money for certain energy and water-related projects. Repayment is made as a special assessment on the annual property tax bill. The special assessment is recorded on the deed and will remain on the parcel, even if the deed is conveyed to a new owner.
