The county realized this error and estimated the city was due 2,586.53 and held the remainder of 14,892.95 in trust until this quarter's report. I have recomputed the correct payment due to the City of Smelterville and a balance of 60.81 is still due to the City of Smelterville for the September's 2012 distribution. For the December distribution the City of Smelterville should receive 2,171.51, in addition the City of Osburn's payement of 12,546.30 should be paid out of the 14,892.95 amount and the remaining 114.33 should be paid to the City of Wardner and the state will pay the difference of 1,271.26.
